## MZ LIQUID FOLIAR SPRAY

### PRODUCT INFORMATION

Dyna Green MZ is a liquid foliar formulation designed for maximum uptake of zinc and manganese and should correct and prevent deficiencies in most citrus. If added to the spray tank first, it will aid in lowering water pH. Check the compatibilities on untried chemical mixes. The addition of a non-ionic surfactant and / or urea nitrogen will aid in uptake.

### DIRECTIONS FOR USE

Dyna Green MZ should be applied at 2-4 quarts per acre in enough water to cover. **Aerial applications:** 1-2 quarts per acre in a minimum of 5 gallons of water per acre. A jar test to check the compatibilities of unfamiliar or new combinations should be performed prior to mixing and application.

### CROP RECOMMENDATIONS

**Citrus & Fruit Crops:** Mature trees: Use 2-4 quarts per acre per application in enough water to cover. Repeat applications in summer and fall sprays as needed.

**Young trees:** Use 2 quarts per 100 gallons of water and wet to run off.

**Pecans:** Use 2-3 quarts per acre in enough water to cover.
