

Dyna-Flo Starter

8-24-8 Complete Liquid Supplement

Information

Dyna-Flo 8-24-8 is a starter fertilizer that may be used both in transplant water and as a foliar spray on ornamental and most seeded and transplanted vegetable crops to encourage early and rapid root development. Dyna-Flo 8-24-8 is designed to give maximum availability of phosphorus and other elements during cool or wet conditions and during the early stages of plant growth.

Crop Recommendations

Citrus: Apply 2-3 quarts per 100 gallons of water per application in transplant solution or as a foliar spray. Use 1 to 2 gallons per tree.

Ornamentals & Foliage Plants: Apply 1 quart per 100 gallons of water as a drench or foliar application. Repeat as needed.

Vegetables: Apply 2 quarts per 100 gallons of water in transplant water and 1 to 2 quarts per 100 gallons of water as a foliar spray.

Turf: Apply 2 quarts per 10,000 sq.ft of lawn on greens in enough water to cover. Repeat 2 to 3 times per year.
