PRODUCT INFORMATION

Dyna Green #2 is a liquid foliar formulation designed to correct and prevent deficiencies on citrus and other tropical fruit crops requiring zinc and manganese. Dyna Green #2 will aid in lowering water pH. A jar test to check the compatibilities of new or unfamiliar combinations should be performed prior to mixing and application. The addition of a non-ionic surfactant will aid in surface coverage and leaf absorption and is recommended for both ground and aerial application.

DIRECTIONS FOR USE

Use 1 to 1½ quarts per 100 gallons of water and apply at a minimum of 100 gallons of water per acre. Severe deficiencies use 2 quarts per 100 gallons of water and apply at a minimum of 100 gallons of water per acre. Aerial application: Should not exceed 2 quarts per 5 gallons of water. Do not apply by air unless a non-ionic surfactant is used equivalent to Triton® CS-7 or Chemical Dynamics Active 80.

CROP RECOMMENDATIONS

For citrus and other tropical fruits requiring zinc and manganese: Apply 1 to 1½ quarts per 100 gallons of water. As a soil drench, use 1 quart per 100 gallons of water.
